<u>Entries</u>: Entries will be submitted on-line through DIRECT ATHLETICS by Thursday, April 8th, 2021, at 10pm. Meet will be on Direct Athletics one week before entry deadline. Each school is allowed A <u>MAXIMUM OF 4 entries in each FIELD EVENT</u> but unlimited in all events on the track. Coaches can **scratch only** at the press box upon your arrival on meet day. **No Additions the day of the meet.**

<u>Awards:</u> Medals will be awarded to the top three places in each individual event and in each relay.

Equipment: Starting blocks will be provided. Each school should provide their own implements and any other equipment needed.

<u>Order of Events:</u> The order of events is listed on the next page. Field events will be given <u>4 attempts</u> with NO finals. There will be no prelims. All running events will be finals.

<u>Scoring</u>: Points will be scored 10-8-6-4-2-1 for individual events and 10-8-6-4-2-1 for relays. <u>A maximum</u> <u>of three individuals may score in any individual event and only one relay may score per school.</u>

<u>Substitutions and additions:</u> No Substitutions or Additions the day of the meet. If you missed something during the regular entry period, please email me or text Coach Woodard before the day of the meet and we will try and make the change.

<u>Pole Vault:</u> Be sure to bring the pole vault verification forms as required by the KSHSAA. Be sure your vault poles are marked correctly. **Starting Heights will be based on entry marks.**

<u>Track Surface and spike regulations:</u> The 400 meter track surface and field event runways are a polyurethane surface that requires spikes no longer than ¹/₄" in length. Please help us monitor this.
